Facts: What does CM Members Federal Credit Union do with your personal information?

Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.

The types of personal information we collect and share depend on the products or services you have with us. This information can include:

- Social security number and income
- Account balances and payment history
- Credit history and credit scores

When you are no longer our member, we continue to share your information as described in this notice.

All financial companies need to share customer's personal information to run their everyday business. In the section below we list the reason financial companies can share their customer's personal information; the reasons CM Members Federal Credit Union chooses to share; and whether you can limit this sharing.
